The Coast Guard is advising mariners to head caution on the water as multiple groups of right whales have been observed in the area of Boston Light to Marshfield. As per the Endangered Species Act, it is unlawful to approach within 500 yards of a North Atlantic right whale by a vessel, aircraft (including drones) or other means, or to fail to take required avoidance measures. Avoidance measures include steering a course away from the whale and immediately leaving the area at a slow, safe speed.

Right whales are surface feeders, which means they are often at the surface or just below the surface when feeding, which makes them hard to see and especially vulnerable to being hit by a vessel.

"North Atlantic right whales are endangered, with a population of only about 450 remaining. It is crucial for people on the water to help protect the whales by adhering to the 500 yard restriction area and vessel speed restrictions. Information about the North Atlantic right whales and vessel speed restriction zone graphics may be found at www.nmfs.noaa.gov/pr/shipstrike.

Last year was devastating for North Atlantic whales, which suffered a loss of 17 right whales, about 4 percent of their population. This is an alarming number for such a critically endangered species.

A single oyster can filter up to 50 gallons of water per day


Roughly 6,000 baby oysters are produced with a bushel of recycled oyster shell

Oysters could once filter a volume of water equal to that of the entire Chesapeake Bay in a week. With their dwindled numbers today it would take more than a year.
